ORDER

University vide read (1) above invited applications for Continuation of Provisional Affiliation for the Academic year 2021-22. In response to the notification, vide read (2) above, the Principal, Believers Church Medical College Hospital, Pathanamthitta had submitted application for Continuation of Provisional Affiliation for the Academic year 2021-22.

2. The inspection commission conducted inspection at the college and submitted inspection report (read 3) which was examined by the scrutiny committee. The committee, vide read (4) above recommended to grant Continuation of Provisional Affiliation to Believers Church Medical College Hospital, Pathanamthitta for conducting the below mentioned courses for the Academic year 2021-22. Vide read (5) above, the Governing council approved the recommendation of the scrutiny committee and decided to grant Continuation of Provisional Affiliation to Believers Church Medical College Hospital, Pathanamthitta for the Academic year 2021-22 subject to receipt of renewal permission /recognition order from the Ministry of Health and Family Welfare Department, Govt. of India.

3. The Principal of the college, vide read (6) above submitted renewal permission /recognition order from the National Medical Commission Under Graduate Medical Education Board for conducting the courses.

4. Sanction has accorded to grant Continuation of Provisional Affiliation to Believers Church Medical College Hospital, Pathanamthitta for the Academic year 2021-22 for conducting the below mentioned courses subject to the conditions detailed below.

i. Selection, admission and collection of fees shall be made only on the basis of the rules and regulations of the

University/Govt. of Kerala and on the basis of the direction issued by the University from time to time, failing which the affiliation granted will be cancelled.

- ii. In the light of the direction of the Supreme Court of India in Writ Petition(c) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the College will be initiated.
- iii. Affiliation granted is strictly provisional and only for the academic year 2021-22. The college has to apply for continuation of provisional affiliation for the ensuing years remitting the fee fixed by the University, along with a copy of letter of approval from the apex bodies concerned. The college should rectify all the deficiencies noted during the last inspection and should submit the compliance to the University urgently.
- iv. The College should remit annual administration fee fixed for UG/PG /Super Specialty courses for the academic year 2021-22 and the college should submit the order reconstituting the Collegé Council for the Academic year 2021-22 at the time of Student Registration .
- v. Admission to the next academic year shall be made only after obtaining prior permission from the University.
